## SEPARATION AGREEMENT

THIS SEPARATION AGREEMENT, made and entered into as of December 1, 2002, by and among W.B. JOHNSON PROPERTIES, L.L.C. ("Johnson Properties"), WBJ HOTELS, LLC ("WBJ Hotels") with Johnson Properties and WBJ Hotels being jointly and severally referred to herein as "Johnson Entities", and WEST PACES HOTEL COMPANY, L.L.C. (the "Hotel Company"), HORST SCHULZE ("Schulze"), PHILIP KEB ("Keb"), and ROBERT WARMAN ("Warman");

### WITNESSETH That:

WHEREAS, Schulze, Keb and Warman are currently the principals (sometimes referred to herein collectively as the "Hotel Company Principals") in the Hotel Company which was formed for the purpose of developing a hotel operating company;

WHEREAS, the Hotel Company and the Johnson Entities (no officer, director, member or other owner of any beneficial interest in Johnson Properties or WBJ Hotels having been involved except through the Johnson Entities) have been working together since the inception of the Hotel Company to develop hotel operating opportunities (the "Business Venture") and in connection therewith the Johnson Entities have invested, directly or indirectly, funds in the Hotel Company;

WHEREAS, the Johnson Entities as a group and the Hotel Company and the Hotel Company Principals as another group have agreed to separate their interests and operate completely independently, and the purpose of this Agreement is to set forth the parties' agreements and undertakings with respect to such separation;

NOW, THEREFORE, for and in consideration of the premises, Ten Dollars and other good and valuable consideration, the receipt and sufficiency of which is acknowledged by the parties hereto, the parties, intending to be legally bound, do hereby agree as follows:

11. Release and Transfer of Trade Names. The Johnson Entities, and all entities controlled by or under common control with the Johnson Entities, hereby transfer, assign and relinquish unto the Hotel Company all right, title and interest in the names "West Paces Hotel Company," "West Paces Hotel Group," "Opus" and any and all derivatives thereof and similar names.

IN WITNESS WHEREOF, each of the parties has caused this Agreement to be executed as of the date and year first above written.
