ASSIGNMENT

Assignee hereby grants Assignor an exclusive, non-transferable, limited and revocable license to Assignor to use the name "Trak Auto" from the Closing Date until a reasonable period after the Turnover Date, but in no case later than November 30, 2002, for the purposes of wrapping up its business operations and the administration of the Chapter 11 case or any subsequent Chapter 7 case. Any capitalized terms not defined herein shall have the meanings set forth in the Asset Purchase Agreement dated as of July 22, 2002, between the parties hereto.
