This Intellectual Property Assignment is between CNA Financial Corporation ("CNA") and RSKCo Services, Inc. ("RSKCo").

WHEREAS, CNA is the owner of all rights, title and interest in the trademarks, copyrights and domain names (collectively, the "Intellectual Property") listed on Exhibit A attached hereto; and

WHEREAS, Continental Casualty Company, an Illinois stock insurance company and a subsidiary of CNA, pursuant to the Stock Purchase Agreement dated as of April 1, 2003 (the "Stock Purchase Agreement"), has agreed to sell all of the issued and outstanding capital stock of RSKCo to Cunningham Lindsey U.S., Inc., a Texas corporation; and


WHEREAS, pursuant to the requirements of the Stock Purchase Agreement, CNA has agreed to assign all rights, title and interest in, to and under the Intellectual Property to RSKCo and RSKCo desires to acquire all of CNA's rights, title and interest in, to and under the Intellectual Property.

NOW, THEREFORE, in consideration of the premises and the mutual covenants and undertakings contained herein and the entering into of the Stock Purchase Agreement and Related Agreements, in reliance upon the representations, warranties, conditions and covenants contained therein, and upon the transactions contemplated thereby, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, CNA does hereby sell, assign, transfer and set over to RSKCo, its successors, legal representatives and assigns, all of CNA's rights, title and interest in and to the Intellectual Property together with the goodwill of the business associated with said Intellectual Property and registrations thereof (including, without limitation, all proceeds thereof and the rights to sue for past, present and future infringements), the same to be held and enjoyed by RSKCo, for its own use and on behalf of its

successors, legal representatives and assigns, as fully and entirely as the same would have been held and enjoyed by CNA, had this sale and assignment not been made.


