

RELEASE OF SECURITY INTEREST (Trademarks)

THIS RELEASE OF SECURITY AGREEMENT (Trademarks) (the "Release") is made and dated as of December 9, 2003, by BANK OF THE WEST, as successor in interest to SANWA BANK CALIFORNIA (the "Bank").

Pursuant to that certain Supplemental Security Agreement (Trademarks) dated as of April 25, 2000 (the "Trademark Security Agreement") by and between BREG, INC. (the "Debtor") and the Bank, the Debtor granted a security interest to the Bank in certain Trademarks to secure obligations of the Debtor to the Bank under that certain Credit Agreement dated as of April 25, 2000, by and between the Debtor and the Bank (as amended, extended and replaced from time to time, the "Credit Agreement"). The Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 5, 2000 on Reel/Frame 002080/0310.
