Assignor owns right, title and interest to trademarks, and related goodwill, used by, or under license from, the Assignor in connection with the design, development, manufacture or distribution of engines and related parts and accessories. An enumeration of these trademarks is attached to the present Assignment as SCHEDULE A; an enumeration of the applications and/or registrations for these trademarks is attached to the present Assignment as SCHEDULE B. Both are together collectively; along with any and all other trademarks, and related goodwill, used by or under license from the Assignor in connection with the design, development, manufacture or distribution of engines and related parts and accessories; hereinafter referred to as the "Trademarks".

Pursuant to an Asset Purchase Agreement between them, Assignor wishes to assign all its right, title and interest to the Trademarks to Assignee.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor does hereby assign to Assignee, its successors, assigns and legal representatives, all its right, title and interest in and to the Trademarks, together with the goodwill of the business symbolized by the Trademarks and any applications and/or registrations therefor in every jurisdiction throughout the world, and the right (but not obligation) to assert the Trademarks and to collect for all past, present and future infringements, and claims for damages and the proceeds thereof, including, without limitation, license royalties and proceeds of infringement suits and all rights corresponding thereto throughout the world by reason of any past or future acts of infringement that have occurred or may occur.

AND, HEREBY, Assignor further covenants and agrees that it will, without further consideration, communicate with the Assignee, its successors and assigns, any facts known to it respecting the Trademarks and will testify in any legal proceedings, sign all lawful papers when called upon to do so, execute and deliver any and all papers that may be necessary or desirable to perfect the title to the Trademarks in the Assignee, its successors or assigns, execute all divisional, continuation, and reissue applications, make all rightful oaths and generally do everything possible to aid the Assignee, its successors and assigns, to obtain and enforce the assignments hereunder and proper protection for the Trademarks in any jurisdiction, it being understood that any expense incident to the execution of such papers shall be borne by the Assignee, its successors, and assigns.

The Assignee and its Agents are hereby authorized to insert into this document any information necessary or desirable for recordation thereof.

The Assignee and its Agents are hereby authorized to insert into SCHEDULE A of this document information pertaining to any trademark sold, assigned, transferred or conveyed to Assignee pursuant to the Asset Purchase Agreement, not appearing in SCHEDULE A.

The Assignee and its Agents are hereby authorized to insert into SCHEDULE B of this document information pertaining to any application or registration for a trademark appearing in SCHEDULE A of this document (including any trademark added to SCHEDULE A under the previous paragraph), not appearing in SCHEDULE B.

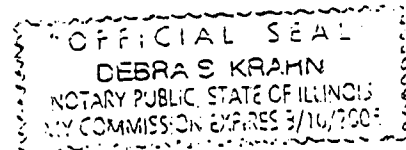
