NUNC PRO TUNC TRADEMARK ASSIGNMENT
Heska Corporation to Alk-Abello, Inc.

WHEREAS, Heska Corporation, a Delaware corporation ("Assignor"), owned all right, title, and interest in the mark CENTER-AL, the United States Trademark Registration No. 956,825 and all related common law rights, including the goodwill associated therewith (the "Trademark") used in the business of Heska Corporation as of June 23, 2000;

WHEREAS, Alk-Abello, Inc., a Delaware corporation ("Assignee"), acquired certain of the assets of Assignor relating to its medical products business pursuant to a certain Asset Purchase Agreement dated as of June 23, 2000 ("the Effective Date"), between Assignee and Assignor (the "Asset Purchase Agreement"); and

WHEREAS, in connection with the Asset Purchase Agreement, Assignee acquired all rights throughout the world in and to the Trademark, any applications and registrations therefor, and any common law rights associated therewith, together with the goodwill of the business with which the Trademark has been used and which is symbolized by the Trademark, along with the right to recover damages and profits for past and future infringements thereof.

NOW, THEREFORE, for the good and valuable consideration set forth in the Asset Purchase Agreement, the sufficiency of which is hereby acknowledged, Assignor did thereby sell, assign, and transfer unto Assignee as of the Effective Date all right, title, and interest in and to the Trademark and any applications or registrations therefor, together with all common law rights therein, the goodwill of the business in connection with which the Trademark has been used and which is symbolized by the Trademark, throughout the world, all renewals thereof, and all rights of action, powers, and benefits accrued thereto, including the right to sue for and collect damages and profits for past and future infringements thereof.
