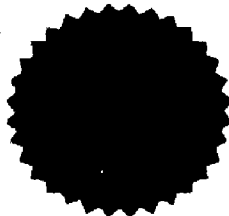

FAST-TALK COMMUNICATIONS, INC., a corporation organized and existing under and by virtue of the laws of the General Corporation Law of the State of Delaware, **DOES HEREBY CERTIFY:**

FIRST: That the Board of Directors of Fast-Talk Communications, Inc. (the "Corporation"), by unanimous written consent of its members in accordance with Section 141 of the General Corporation Law of the State of Delaware, filed with the minutes of the board, duly adopted resolutions proposing and declaring advisable an amendment to the Corporation's Certificate of Incorporation to change the name of the Corporation as set forth herein and recommending that such amendment be submitted to the stockholders of the Corporation for their consideration, action and approval.

SECOND: That Article First of the Certificate of Incorporation of the Corporation hereby is amended by deleting such Article in its entirety and substituting in lieu thereof the following:

"FIRST: The name of the Corporation is Nexidia Inc."

THIRD: That, pursuant to Sections 228 and 242 of the General Corporation Law of Delaware, the aforesaid amendment to the Certificate of Incorporation was approved by the stockholders of the Corporation by written consent dated September 8, 2003.

FOURTH: That the foregoing amendment was duly adopted in accordance with the provisions of Section 242 of the General Corporation Law of the State of Delaware.
