## ASSIGNMENT OF INTELLECTUAL PROPERTY SECURITY INTEREST

This Assignment of Intellectual Property Security Interest dated as of September 30, 2002, is made by and between **WACHOVIA BANK, NATIONAL ASSOCIATION**, formerly known as First Union National Bank, a national banking association ("Assignor"), having an address of One Wachovia Center, 301 South College Street, 5th Floor, Charlotte, North Carolina 28288 and **CONGRESS FINANCIAL CORPORATION (SOUTHERN)**, a Georgia corporation ("Assignee"), having an address at 200 Galleria Parkway, Suite 1500, Atlanta, Georgia 30339.

1. Transfer and assign to Assignee all right, title and interest of Assignor pursuant to the Trademark Assignment in the Trademarks, together with all rights, remedies and benefits granted to Assignor under the Trademark Assignment; and

2. Authorizes and requests the Commissioner of Patents and Trademark of the United States of America to note and record the assignment provided for herein.




