

TRADEMARK/SERVICE MARK ASSIGNMENT

THIS AGREEMENT ("Agreement"), effective November 21, 2003, is between eSpeed, Inc., a Delaware corporation with its principal place of business at 135 East 57th Street, New York, New York 10022 ("eSpeed") and Arbitration Forums, Inc., a New York corporation with a principal place of business at 3350 Buschwood Park Drive, Suite 295, Tampa, Florida 33618 ("Arbitration Forums").

Further, Arbitration Forums hereby assigns all worldwide rights, title and interest it may have in the E-SPEED FILING Mark together with the good will of the business symbolized by the E-SPEED FILING Mark, and any foreign applications and/or registrations therefor, and with all claims that could be asserted by Arbitration Forums arising out of or relating to the use or ownership of the E-SPEED FILING Mark.

2. Arbitration Forums agrees that upon request by eSpeed it shall execute or arrange to have executed any and all further documents as are necessary and/or required to effectuate the recording of this assignment of the E-SPEED FILING Mark and the identified application therefor.

3. The undersigned representative of Arbitration Forums, being hereby warned that willful false statements and the like so made are punishable by fine or imprisonment, or both, under Section 1001 of Title 18 of the U.S. Code and that such willful false statements may jeopardize the validity of the identified United States application or any registrations resulting therefrom, declares: that he/she is an officer of Arbitration Forums, the Assignor corporation, and is authorized to execute this instrument on behalf of said corporation; and that all statements made of his knowledge are true and all statements made on information and belief are believed to be true.
