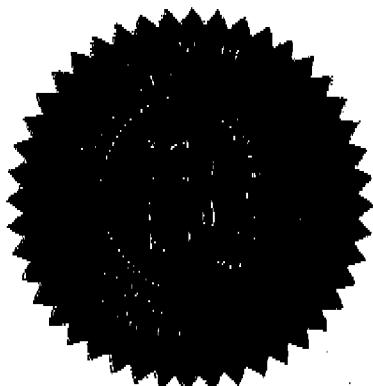

Burt M. Martin, being duly sworn, deposes:

1. That he is the Secretary of Weatherford U.S., L.P., a Louisiana Limited Partnership (the "Partnership"), having its principal place of business at 515 Post Oak Boulevard, Suite 600, Houston, Texas; and
2. That, as such Secretary, he has in his custody the corporate records of the Partnership and is cognizant of the Partnership's history.
3. That on November 19, 1998, the Partnership's general partner, Weatherford U.S., Inc., changed its name to Weatherford Holding U.S., Inc. ("WHUSI").
4. That effective as of December 31, 1999, WHUSI adopted a Plan of Liquidation and entered into a General Conveyance and Assignment Agreement, whereby it conveyed its interest in the Partnership to its ultimate shareholder, Weatherford International, Inc., which, in turn, contributed its interest in the Partnership to a new general partner, WUS Holding, L.L.C.
5. That effective as of December 19, 2000, WHUSI was dissolved and that WUSLP is now its successor-in-interest.

IN WITNESS WHEREOF, the Partnership has caused its corporate seal to be hereunto affixed on the 21st day of November 2003.

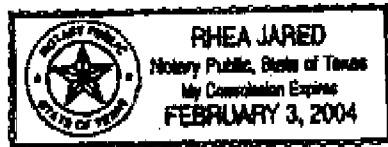
