TRADEMARK ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound, the parties hereto agree as follows:

(1) White Knight Engineered Products, Inc., a Delaware corporation (“Assignor”), having an office and place of business at 4080 McGinnis Ferry Road, Suite 1303, Alpharetta, Georgia 30005, and the owner of all right, title and interest to the trademarks and trademark applications listed below (the “Marks”), hereby sells, assigns and transfers unto E. I. du Pont de Nemours and Company, a Delaware corporation (“Assignee”), having an office and place of business at 1007 Market Street, Wilmington, Delaware 19898, its successors, assigns and legal representatives, its entire right, title and interest in and to the Marks.

(2) Assignor hereby agrees that it will from time to time, if requested by the Assignee or the successors or assigns of the Assignee, execute, acknowledge and deliver, or cause to be executed and delivered to Assignee or its successors or assigns such and all further acts, transfers, assignments, transfer documents, powers and assurances of title and additional papers and instruments that may be necessary or desirable to carry out the intent hereof and to vest in Assignee the entire right, title and interest of Assignor in and to the Marks throughout the world. Assignor agrees that he will assist Assignee or its successor or assigns with applications to register any of the Marks in any jurisdiction in the world where they are not now registered including, without limitation, helping to establish priority of use or satisfy any other predicates for registration.

(3) All capitalized terms used but not defined herein shall have the meaning assigned to such terms in the Asset Purchase Agreement, dated as of June 27, 2003 (the “Asset Purchase Agreement”), by and among the Buyer, the Seller and Thantex Holdings, Inc., the parent of the Seller. Assignor and Assignee hereby acknowledge and agree that neither the representations and warranties nor the rights, remedies and obligations of any party under the Asset Purchase Agreement shall be deemed enlarged, modified or altered in any way by this Trademark Assignment.


