Martin does hereby covenant and agree with Monessen to execute and deliver such other and further instruments and to take such other and further actions as may be reasonably necessary and appropriate to transfer the Trademarks, claims for damages by reason of past infringement and right to sue and collect therefor to Monessen.

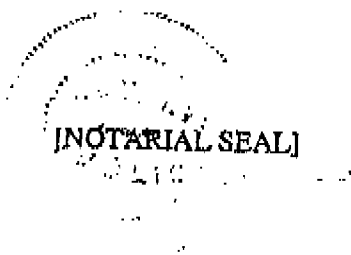
