

IN WITNESS WHEREOF, Assignor has executed this Assignment by its Manager this 17th day of October, 2003.

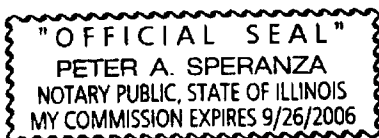


