

Breuner, II did sell and assign, and now confirms, *nunc pro tunc*, that he sold and assigned to Trukke Winter Sports Products, Inc. its successors, legal representatives and assigns, on or before August 26, 2001, the entire right, title and interest in and to the application 08/874,904 and to any U.S. patent application and any U.S. patent issuing thereon, for its own use and the use of its successors, legal representatives, and assigns forever and to the full end of the term or terms for which said Letters Patent may be granted, as fully and entirely as the same would have been held and enjoyed by Richard W. Breuner, II, had this Assignment not been made and with the right to recover and have damages and profits for past infringements, if any.
