TRADEMARK ASSIGNMENT

WHEREAS, Spaulding Composites Company, Inc., a New Hampshire corporation, having a principal place of business at 1 Monogram Place, Rochester, New Hampshire 03866 (the "Assignor"), is the owner of the entire right, title and interest in and to the trademarks and trademark applications (the "Trademarks") listed on the Schedule of Trademarks attached hereto as Exhibit A;

WHEREAS, Spaulding Acquisition Co., a Delaware corporation, having a principal place of business at c/o Three Centennial Drive, Peabody, Massachusetts 01960 (the "Assignee"), is desirous of acquiring all right, title and interest in said Trademarks, in the United States and in any and all foreign countries;

WHEREAS, on February 8, 2001 the Assignor commenced a proceeding under Chapter 11 of the United States Bankruptcy Code (Case No. 01-10346-JMD) in the United States Bankruptcy Court for the District of New Hampshire (the "Bankruptcy Court");

WHEREAS, pursuant to an Acquisition Agreement, dated as of October 3, 2003, as amended by the First Amendment to and Assignment of Acquisition Agreement, dated as of October 9, 2003 (as so amended, the "Acquisition Agreement"), by and between the Assignor and the Assignee, the Assignor agreed to sell to the Assignee, and the Assignee agreed to purchase from the Assignor, all of the assets and properties of the Assignor used in the laminates business of the Assignor, including but not limited to the Trademarks (collectively, the "Laminate Assets"); and

WHEREAS, pursuant to an Order, dated October 9, 2003 (the "Sale Order"), the Bankruptcy Court approved the sale of the Laminate Assets, free and clear of substantially all liens, claims and encumbrances, to the Assignee on the terms set forth in the Acquisition Agreement and the Sale Order;

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, the Assignor does hereby assign, sell and transfer unto the Assignee all right, title and interest in and to the Trademarks, including all common law rights, along with the goodwill of the business symbolized by the Trademarks. Assignor further assigns, sells and transfers to Assignee the right to sue and collect damages for any and all past and present infringement of any rights in the Trademarks.
