

TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (the "Assignment") is made and entered into as of the 17th day of December, 2003 by and between Randstad Staffing Services, Inc., a Georgia corporation located at c/o Randstad North America, L.P., 2015 South Park Place, Atlanta, Georgia 30339 ("Assignor") and Randstad General Partner (US) LLC, a Delaware limited liability company located at 2015 South Park Place, Atlanta, Georgia 30339 ("Assignee") (collectively, the "Parties").

WITNESSETH

WHEREAS, Assignor has adopted and used and is the owner of the trademark FLEXLIFE (the "Mark"), and the Registration as set forth on Schedule A attached hereto and incorporated herein by this reference (the "Registration"); and

WHEREAS, Assignor is the owner of all right, title and interest in and to the Mark and Registration; and

WHEREAS, Assignee and Assignor desire to enter into this Assignment to effect the transfer to Assignee of the Mark and Registration;

NOW, THEREFORE, for and in consideration of the premises and the mutual promises hereinafter set forth and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee hereby agree as follows:

1. Transfer and Assignment. Assignor hereby transfers and assigns to Assignee all right, title and interest in and to the Mark and Registration, together with the goodwill associated therewith and the right to recover for damages and profits and other remedies for past infringements of the Mark and Registration.

2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and/or instruments, and to perform further acts, as reasonably deemed necessary by the Parties, to vest in Assignee all right, title and interest in and to the Mark and Registration, to enable such right, title and interest to be recorded in the appropriate governmental authority or agency and reasonably assist Assignee in its efforts to enforce the Mark and Registration.
