# TRADEMARK AND DOMAIN NAME ASSIGNMENT

1. RBMC does hereby sell, assign and set over unto SSA all rights, title, and interest in and to (1) said mark and the application for registration therefor, together with the good will of the business symbolized by the mark and (2) said domain name;
2. RBMC acknowledges that this assignment is only effective to transfer the ownership in the mark SPEEDWAY SUPERSTORE.COM and the domain name SPEEDWAYSUPERSTORE.COM to SSA, and RBMC expressly retains any liabilities which have arisen or may arise in the future as a result of RBMC's ownership and use of said mark and domain name.

3. Upon receipt of an original of this Assignment which has been executed by RBMC, SSA will pay RBMC the sum of Two Thousand Dollars (\$2,000.00). Upon receipt of this sum, RBMC shall cause the registrar of the domain name to transfer said name to SSA from the current registrant.
