**WHEREAS**, ASSIGNEE is desirous of acquiring the Marks and the Registrations, together with the goodwill of the business associated the Marks and the Registrations, in a form acceptable for recordation by the United States Patent and Trademark Office;

**NOW, THEREFORE**, for good and valuable consideration, the receipt of which is hereby acknowledged, ASSIGNOR hereby assigns to ASSIGNEE all right, title and interest in and to the Marks and the Registrations, together with the goodwill of the business associated the

Marks and the Registrations, and together with all claims for damages by reason of past infringement thereof, with the right to sue for, and collect the same for its own use and benefit, and for the use and benefit of its successors, assigns and legal representatives.
