It is hereby verified that, pursuant to Section 253 of the General Corporation Law of the State of Delaware:

1. IDG BOOKS WORLDWIDE, INC. hereinafter sometimes referred to as the "Corporation" is a business corporation of the State of Delaware.

RESOLVED that this Corporation shall cause to be executed and filed and/or recorded the documents prescribed by the laws of the State of Delaware and by the laws of any other appropriate jurisdiction and will cause to be performed all necessary acts within the State of Delaware and within any other appropriate jurisdiction.

RESOLVED that this Corporation shall change its corporate name to Hungry Minds, Inc.

RESOLVED that the effective time of the Certificate of Ownership and Merger setting forth a copy of these resolutions, and the time when the merger therein provided for, shall become effective shall be November 13, 2000.
