

TERMINATION OF NOTICE OF SECURITY INTEREST IN TRADEMARKS


WHEREAS, Decision Resources, Inc., a Massachusetts corporation, whose address is 17 New England Executive Park, Burlington, Massachusetts 01803 (the "Company"), and State Street Bank and Trust Company, a Massachusetts trust company, whose address is P.O.
