

## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS ("Release") is executed by WACHOVIA BANK, National Association (successor by merger to Wachovia Bank, N.A., a national banking association) ("Assignor"), as Administrative Agent for the Lenders under that certain Company Trademark Security Agreement dated as of May 18, 1998 and under that certain Subsidiary Trademark Security Agreement dated as of May 18, 1998, each by and between FHC HEALTH SYSTEMS, INC., the entities listed on Exhibit A hereto (each, a "Grantor") and Assignor, as Administrative Agent (together, the "Agreements"). Capitalized terms used in this Release and not defined herein shall have the meanings assigned to such terms in the Agreements, whether by reference to another agreement or otherwise.

WHEREAS, in connection with the Agreements, each Grantor assigned to Assignor, and granted to Assignor, a security interest in all of such Grantor's right, title and interest in and to each of the Trademarks and rights and interests in Trademarks that were then, or are now, owned, held (whether pursuant to a license or otherwise) or used by such Grantor, in whole or in part (including, without limitation, the Trademarks specifically identified in Schedule A hereto), and including all Trademark Rights with respect thereto and all foreign, federal, and state Registrations therefor theretofore or thereafter granted or applied for, the right (but not the obligation) to register claims under any state or federal trademark law or regulation or any trademark law or regulation of any foreign country and to apply for, renew and extend the Trademarks, Registrations and Trademark Rights, the right (but not the obligation) to sue or bring opposition or cancellation proceedings in the name of such Grantor or in the name of Secured Party or otherwise for past, present and future infringements of the Trademarks, Registrations or Trademark Rights and all rights (but not obligations) corresponding thereto in the United States and any foreign country, and the Associated Goodwill; it being understood that the rights and interests included herein shall include, without limitation, all rights and interests pursuant to licensing or other contracts in favor of such Grantor pertaining to the Trademarks, Registrations or Trademark Rights then or now owned, held or used by third parties, in each case whether then or thereafter existing or in which such Grantor then had or thereafter acquired an interest and wherever the same may have been located (collectively, the "Trademarks");

WHEREAS, the Agreements were recorded in the United States Patent and Trademark Office on June 22, 1998 at: (i) Reel 1746, Frame 0001; (ii) Reel 1746, Frame 0249; (iii) Reel 1746, Frame 0297; (iv) Reel 1747, Frame 0118, and on September 28, 1999 at Reel 1967, Frame 0824, and


WHEREAS, the Assignor has agreed, for good and valuable consideration, to release its liens in the Trademarks.
