

RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT

RELEASE OF TRADEMARK AND PATENT SECURITY AGREEMENT, dated as of December 12, 2003 (this "Agreement"), by LASALLE BUSINESS CREDIT, INC. ("LASALLE") with an office located at 135 South LaSalle Street, Chicago, IL 60603. Capitalized terms used herein without being defined herein shall have the respective meanings provided therefor in the Credit Agreement referred to below.

WITNESSETH:

WHEREAS, LASALLE and Command Security Corporation, a New York Corporation ("COMMAND") are parties to a certain Loan and Security Agreement dated as of November 10, 2000, (as amended to the date hereof, the "Loan and Security Agreement"), whereby LASALLE has made certain loans and other financial accommodations (the "Loans") to COMMAND; and

WHEREAS, as partial security for COMMAND's Obligations, as that term is used herein and is defined in the Loan and Security Agreement, COMMAND has executed a certain Trademark and Patent Security Agreement (the "Trademark and Patent Security Agreement") dated November 10, 2000, pursuant to which COMMAND granted a security interest in and to the Collateral listed on Schedule A attached hereto, as that term is used herein and is defined in the Trademark and Patent Security Agreement; and

WHEREAS, the Trademark and Patent Security Agreement was executed on November 10, 2000; and

WHEREAS, the Obligations have been fully satisfied and, therefore, COMMAND has requested that LASALLE release its security interest in the Collateral listed in Schedule A attached hereto and reassign the same to COMMAND.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

- (1) LASALLE hereby releases its security interest in LASALLE's rights, title and interest in and to the Collateral listed on Schedule A attached hereto, as such rights, title and interest are granted in the Trademark and Patent Security Agreement.
- (2) LASALLE hereby reassigns, grants and conveys to COMMAND, without any representation, recourse or undertaking by LASALLE, all of LASALLE's rights, title and interest in and to the Collateral, as such rights, title and interest are
