TRADEMARK ASSIGNMENT

WHEREAS, Avon Rubber p.l.c., a British company, having its principal place of business at Manvers House, Kingston Road, Bradford-on-Avon, Wiltshire, BA 15 1AA, the United Kingdom ("Avon Rubber") is the record owner of the entire right, title and interest in and to the trademark registrations identified on the attached Schedule A (the "Trademarks"); and

WHEREAS, Avon Rubber has agreed to assign and transfer its entire right, title and interest in and to the Trademarks, together with all of the goodwill associated therewith and symbolized thereby, including all common law rights associated with the Trademarks by virtue of their use in commerce, to Cadillac Rubber & Plastics, Inc., a Michigan corporation, having its principal place of business at 805 West Thirteenth Street, Cadillac, Michigan, 49601, U.S.A. ("Cadillac Rubber"); and

WHEREAS, Cadillac Rubber has agreed to assign and transfer its entire right, title and interest in and to the Trademarks, together with all of the goodwill associated therewith and symbolized thereby, including all common law rights associated with the Trademarks by virtue of their use in commerce, to Kelly Interests, Ltd., a Texas limited partnership, having its principal place of business at 1519 Chestnut Grove Lane, Kingwood, Texas 77345, U.S.A. ("Kelly Interests"); and


NOW, THEREFORE, TO ALL WHOM IT MAY CONCERN, in view of the premises herein and in consideration of the sum of One Dollar (\$1.00) and other valuable and legally sufficient consideration, the receipt of which is hereby acknowledged by Avon Rubber and Cadillac Rubber, Avon Rubber does hereby sell, convey, transfer and assign and deliver unto Kelly Interests, its successors and assigns, the entire right, title and interest in and to the Trademarks, together with the goodwill associated therewith and symbolized thereby, and in and to any and all renewals thereof, together with all rights to sue and recover for past infringement thereof, to have and to hold forever for the sole and exclusive use and benefit of Kelly Interests.

Avon Rubber hereby consents that a copy of this ASSIGNMENT shall be deemed a full legal and formal equivalent of any assignment, consent to file, or like document that may be required in any particular country for any purpose and more particularly in proof of the right of Kelly Interests to claim the aforesaid benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended.


