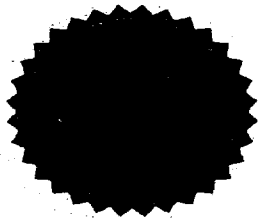

The undersigned, being the President of Schiapparelli Biosystems, Inc., a corporation organized and existing under the laws of the State of Delaware, does hereby certify as follows:

FIRST: The name of the corporation is Schiapparelli Biosystems, Inc.


SECOND: That the Certificate of Incorporation of Schiapparelli Biosystems, Inc. is hereby amended by deleting Article FIRST thereof in its entirety and inserting in lieu thereof a new Article FIRST reading in its entirety as follows:

"FIRST: The name of the corporation (hereinafter called the "Corporation") is Alfa Wassermann, Inc."

THIRD: The amendment set forth above has been duly adopted in accordance with the provisions of Sections 141(f), 228 and 242 of the General Corporation Law of the State of Delaware by a unanimous written consent of the Board of Directors of the Corporation dated as of September 21, 1999 and by a written consent of sole stockholder dated as of October 6, 1999.
