**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARK RIGHTS**

TERMINATION AND RELEASE dated as of December 11, 2003, from **BANK OF AMERICA, N.A.**, as Collateral Agent (the "Collateral Agent") for certain lenders (the "Lenders") with principal offices at Charlotte, North Carolina, to **MEDICAL STAFFING NETWORK ASSETS, LLC**, an Illinois limited liability company, with its principal offices at 161 S. Lincolnway, Suite 208, North Aurora, IL 60542 (the "Assignor").

WITNESSETH:

WHEREAS, pursuant to the Security Agreement, dated as of October 26, 2001, made by the Assignor and the other parties signatory thereto in favor of the Collateral Agent (the "Security Agreement"), a security interest (the "Security Interest") was granted by the Assignor to the Collateral Agent in certain collateral, including the Trademark Collateral (as hereinafter defined);

WHEREAS, pursuant to that certain Grant of Security Interest in Trademarks of Medical Staffing Network Assets, LLC (the "Granting Agreement") in favor of Collateral Agent, the Assignor granted a Security Interest to the Collateral Agent in its Trademark Collateral;

WHEREAS, the Granting Agreement was recorded in the Assignment Division of the United States Patent and Trademark Office on November 17, 2003, at Reel 002747 and Frame 0799; and

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:

1. **Definitions:** The term "Trademark Collateral," as used herein, shall mean, as of the date hereof, all of the Assignor's right, title and interest of every kind and nature in (i) its trademarks, trademark registrations and trademark applications ("Marks") including those set forth on Schedule A hereto, (ii) all Proceeds (as such term is defined in the Security Agreement) and products of such Marks, (iii) the goodwill of the business symbolized by the Marks and (iv) any and all causes of action arising prior to or after the date hereof for infringement of any of the Marks or unfair competition regarding the same.

2. **Release of Security Interest:** The Collateral Agent hereby terminates, releases, discharges, quitclaims and relinquishes its Security Interest in the Trademark Collateral, and any right, title or interest of the Collateral Agent in such Trademark Collateral shall hereby cease and become void.

3. Further Assurances: The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby.

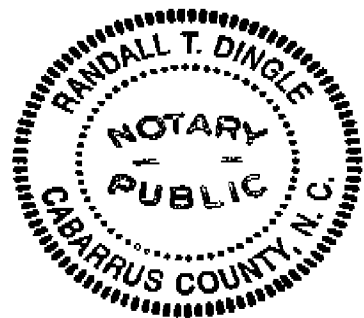
