- (2) Brand-Rex Limited (formerly Caradon Brand-Rex Limited) a company incorporated in England and Wales under number 2340157, whose registered office is at 24 Queens Road, Weybridge, Surrey, KT13 9UX (the Assignee).

Whereas:

- (A) The Assignor is the registered proprietor and beneficial owner of the intellectual property rights described in the Schedule (the Intellectual Property);
- (B) Pursuant to a Sale and Purchase Agreement dated 4 March 2000 the Assignor has agreed to assign the Intellectual Property to the Assignee.

IT IS AGREED as follows:

1 Assignment

Pursuant to the Sale and Purchase Agreement and in consideration of £7,438.02 (seven thousand four hundred and thirty-eight pounds and two pence) the Assignor with full title guarantee hereby assigns to the Assignee free from any third party loans, charges and encumbrances and subject only to the intellectual property licences listed in Schedule 14 of the Sale and Purchase Agreement all its right, title and interest in the Intellectual Property together with all statutory and common law rights attaching thereto including the right to sue for damages and other remedies in respect of any infringement or misuse of the Intellectual Property which may have occurred prior to the date of this Agreement.

2 Further Assurance

The Assignor agrees to execute such documents and provide such assistance as may be reasonably required by the Assignee to obtain the full benefit of the assignment set out above. The Assignee will reimburse the Assignor's reasonable expenses incurred in so doing, subject to any provision in the Sale and Purchase Agreement to the contrary.

3 Counterparts

This Agreement may be executed in any number of counterparts or duplicates, each of which shall be an original, and such counterparts or duplicates shall together constitute one and the same agreement.


