TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, from JOS. A. WHEREAS, Assignor desires to assign, and Assignee desires to acquire by this instrument, all of Assignor's right, title and interest in and to the Trademark, all goodwill associated therewith, and all common law rights therein.

NOW, THEREFORE, in consideration of the foregoing premises, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor hereby sells, assigns and transfers to Assignee, its successors and assigns, all of Assignor's right, title and interest in and to the Trademark, including federal and common law rights and U.S. Registration No. 2,128,802 for the Trademark, together with all of the goodwill symbolized by and associated with the Trademark, all income, royalties, fees and payments now or hereafter due or payable with respect thereto, and the right to file any action and recover damages for any present or future infringement or misappropriation of the Trademark or any other rights assigned to Assignee under this Assignment.

Assignor hereby agrees to execute, acknowledge and deliver to Assignee all documents as may be necessary to make a record with any government agencies, courts or third parties of Assignee's ownership of all rights, title and interest in and to the Trademark and the goodwill associated therewith.
