## ASSIGNMENT OF TRADEMARK

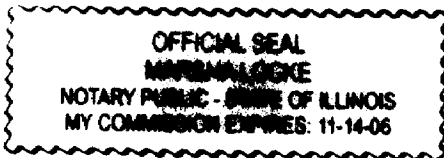
