WHEREAS, BRUNSWICK CORPORATION, a corporation organized and existing under the laws of the State of Delaware, with its principal place of business at One North Field Court, Lake Forest, Illinois 60045-4811, wishes to acquire the marks, registrations, applications for registration and associated goodwill set forth on Schedule A to this Assignment and **NELSON/WEATHER-RITE, INC.** wishes to sell and transfer said marks, registrations, applications and goodwill set forth on Schedule A to this Assignment to **BRUNSWICK CORPORATION,** all pursuant to the Asset Purchase Agreement dated as of February 26, 1996 (the "Purchase Agreement"), among **NELSON/WEATHER-RITE, INC.,** certain affiliates thereof and **BRUNSWICK CORPORATION;** and

NELSON/WEATHER-RITE, INC. shall, at BRUNSWICK CORPORATION'S reasonable request, execute and deliver to BRUNSWICK CORPORATION any and all agreements, instruments and other documents of any kind or character, and perform all such other actions, that may be necessary or desirable to facilitate and effectuate the terms and provisions of this Assignment.

This Assignment shall be binding upon NELSON/WEATHER-RITE, INC. and its successors and assigns, and shall inure to the benefit of BRUNSWICK CORPORATION and its successors and assigns.

This Assignment shall be governed by, and construed in accordance with, the laws of the State of Delaware, without regard to principles of conflicts of law.
