ASSIGNMENT OF REGISTRATION OF A MARK
AND ACKNOWLEDGEMENT THEROF

WHEREAS, Mountain Hardwear, Inc., a corporation of the State of Utah, having a place of business at 4911 Central Avenue, Richmond, California, hereinafter referred to as "Assignor", has been the owner of all rights in U.S. Registration No. 2,392,126, registered October 3, 2000, of the Mark "MOUNTAIN LINK", and of the Mark itself;

WHEREAS, Mountain Link, Inc., a corporation of the State of California, having a place of business at 4911 Central Avenue, Richmond, California, hereinafter referred to as "Assignee", has desired to acquire the entire right, title and interest in and to said Registration and Mark, including the goodwill associated therewith;

WHEREAS, the parties have agreed for Assignor to assign all right, title, and interest in and to said Registration and Mark, including the goodwill associated therewith, and do hereby acknowledge same;

NOW, THEREFORE, for One Dollar (\$1.00) and other good and valuable consideration received by Assignor from Assignee, the receipt of which is hereby acknowledged by Assignor, and to the extent not already assigned, the parties do hereby assign as follows:

1. Assignor sells, assigns, transfers and conveys to Assignee the entire worldwide right, title and interest in and to said Mark, and of the above identified Registration thereof, and the goodwill associated therewith, together with all claims, and Registration or for unfair competition in business in connection therewith whatsoever or by whomsoever committed; said interest to be held and enjoyed by Assignee as fully and exclusively as it would have been held and enjoyed by said Assignor had this Assignment and transfer not been made;

2. Except as above described as between the parties, Assignor hereby warrants, covenants and represents that it has not heretofore granted any license, right or privilege with

respect to said Mark and Registration or in any other way encumbered the same, and that Assignor has the full right to make this Assignment; and

3. The terms, covenants and provisions of this Assignment shall inure to the benefit of Assignee, its successors, assigns and other legal representatives, and shall be binding upon Assignor, the Assignor's heirs, legal representatives and assigns.
