IN WITNESS WHEREOF, the Grantor has executed this Quitclaim Deed as of the day and year set out above.

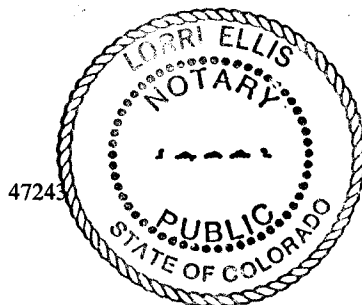
