

Whereas, ASSIGNEE desires to obtain the entire right, title and interest in and to said trademarks and the registrations therefor and has prepared this Trademark Assignment.


Now, therefore, to all whom it may concern:

damages or profits by reason of past infringement of said trademarks, the application and the registrations therefor, and the right to sue for and collect the same.


