ARTICLES OF CONVERSION
of

Pursuant to the provisions of Article 10.09 of the Texas Limited Liability Company Act (the "LLC Act") and Article 6132a-1 § 2.15(e) of the Texas Revised Limited Partnership Act ("TRLPA"), the undersigned converting entity, Klass Time, LLC, a Texas limited liability company (the "Company"), hereby certifies to and authorizes the filing with the Office of the Secretary of State of Texas the following Articles of Conversion for the purpose of converting the Company into the converted entity, Klass Time, Ltd., a Texas limited partnership ("Partnership"):

ARTICLE ONE

A copy of the Plan of Conversion has been furnished to the sole member of the converting entity and shall be furnished, upon written request and without cost, to any of the partners of the converted entity after conversion.

ARTICLE FIVE

The converted entity will be responsible for the payment of all fees and taxes, as required by law.

ARTICLE SIX


