INTELLECTUAL PROPERTY ASSIGNMENT AGREEMENT


WHEREAS, Robert M. Grace, an individual, Bobby Grace Putters LLC, a Florida limited liability company with offices at 4910-A Creekside Drive, Clearwater, FL 33760, and BG GOLF CLASSICS, INC. (formerly known as Bobby Grace Golf Design, Inc.), a Florida corporation with offices at 12200 28th Street North, St. Petersburg, FL 33176 (collectively, the "Assignor"), have acquired certain right, title and interest in and to certain trademarks, copyrights, patents, patent applications, trade secrets and other intellectual property rights; and


WHEREAS, Assignor and MacGregor Golf Company, a Delaware corporation with offices at 1000 Pecan Grove Drive, Albany, GA 31701 (the "Assignee"), are simultaneously herewith entering into an Asset Purchase Agreement (the "Purchase Agreement"), pursuant to which Assignee is acquiring certain assets and property used by Assignor and it is desirous of acquiring all intellectual property and associated goodwill owned by the Assignor, more specifically defined as: (1) all trademarks, service marks, or trade names, including but not limited to those shown in Schedule A hereto, and any other trademarks owned or used by Assignor (the "Trademarks"); (2) all copyrights, rights of reproduction and copyrightable subject matter, whether registered or not, owned by Assignor, including but not limited to those shown in Schedule A hereto, and used in or otherwise related to the Assignor's business and products (the "Copyrights"); (3) all domestic and foreign patents and patent applications, including but not limited to those shown in Schedule A hereto, and any other patent rights owned by Assignor (the "Patents"); (4) all information, know-how and show-how (including without limitation, data, documents, drawings, software, procedures, customer lists and other proprietary materials) relating to, without limitation, the specification, examination, simulation, design, implementation, processing, manufacture, procurement of, sale and delivery of Assignor's products (the "Trade Secrets"); (5) all maskworks and maskwork applications (the "Maskworks") owned by Assignor, including but not limited to those shown in Schedule A hereto; and (6) all other intellectual property or other proprietary rights owned by Assignor not identified above (the "Proprietary Rights").

NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged and intending to be legally bound, Assignor hereby sells, assigns and transfers to Assignee all of its right, title and interest in and to: (1) the Trademarks, Copyrights, Patents, Trade Secrets, Maskworks, and Proprietary Rights (collectively, the "Intellectual Property"); (2) all income, royalties, damages and payments now or hereafter due or payable with respect to the Intellectual Property; (3) all rights of action arising from the Intellectual Property; (4) all claims for damages by reason of past, present and future infringement or misappropriation of the Intellectual Property; and (5) the right to sue and collect damages for such infringement, to be held and enjoyed by Assignee for its own use and benefit and for its successors and assigns as the same would have been held by Assignor had this assignment not been made.


