Assignor shall cooperate with Assignee, at Assignee's request, to execute all documents reasonably necessary to perfect the interests assigned hereby, and Assignor has not executed and will not execute any agreement in conflict with this Trademark Assignment.

All representations, warranties, covenants and agreements made by the parties in the Asset Purchase Agreement among Baxter Healthcare SA, a company organized under the laws of Switzerland, Baxter Healthcare Corporation, a Delaware corporation, and Assignee effective the date hereof shall survive this Trademark Assignment and not be merged herein.
