**ASSIGNMENT OF WHOLESALE AGREEMENTS

**NOW, THEREFORE, FOR GOOD AND VALUABLE CONSIDERATION**, the receipt and sufficiency of which Assignor and Assignee mutually hereby expressly acknowledge, to the extent of its respective interests therein, each entity comprising Assignor hereby assigns, conveys, transfers and sets over unto Assignee, all of Assignor's right, title and interest in and to all Wholesale Agreements and Intangible Property, including, but not limited to, its right, title and interest in and to the Wholesale Agreements and Intangible Property identified on Schedule 1 attached hereto and incorporated herein by this reference. This Assignment shall inure to the benefit of, and be binding upon, the successors, executors, administrators, legal representatives and assigns of Assignor and Assignee.

Notwithstanding anything to the contrary herein, the parties comprising Assignor are executing and delivering this Assignment in accordance with and subject to all of the terms and provisions of and the disclaimers and limitations set forth in the Agreement.

This Assignment shall be governed by and construed and enforced in accordance with the laws of Delaware.
