TRADEMARK ASSIGNMENT AGREEMENT

UNITED STATES TRADEMARK ASSIGNMENT

THIS ASSIGNMENT, made as of the 12th day of December, 2003, by and between Fujisawa Healthcare, Inc. NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00) and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Assignor does hereby sell, grant, assign, transfer, convey and deliver to Assignee all of its right, title and interest in and to the Mark, together with the goodwill of the business in connection with which the Mark is used.
