## TRADEMARK ASSIGNMENT

all rights of ASSIGNOR associated therewith, including the right to claim priority rights deriving from the TRADEMARKS by virtue of international convention, treaty or otherwise, all claims for damages by reason of past infringements of the TRADEMARKS, and the right to sue and collect such damages.

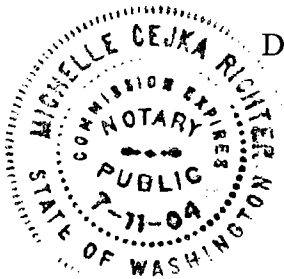

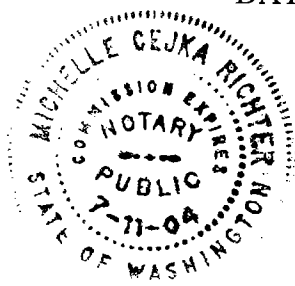
