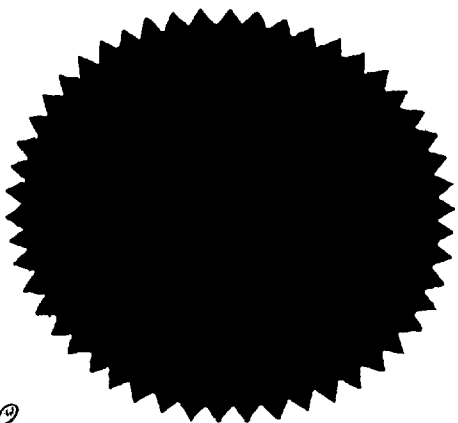

ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
BERKLEY INC.

TO THE SECRETARY OF STATE OF THE STATE OF IOWA:

Pursuant to section 1006 of the Iowa Business Corporation Act, the undersigned corporation adopts the following amendment to the corporation's Articles of Incorporation:

- 1. The name of the corporation is Berkley Inc.
- 2. The Restated Articles of Incorporation, as amended, shall be further amended by striking ~~Article I in its entirety and inserting in lieu thereof the following new Article I:~~

"The name of the corporation is Pure Fishing, Inc."

- 3. The date of adoption of the amendment was June 19, 2000.
- 4. The amendment was approved by the shareholders.
