WHEREAS, Assignor has acquired goodwill associated with and symbolized by said Trademarks and has not abandoned the same.

WHEREAS, on March 25, 2002, a trademark application for the mark HOTROD & RESTORATION and Design as depicted on Schedule B attached hereto (Application Serial No. 76/386,684) (hereinafter referred to as "Application") was filed in the name of James Lewis based on a bona-fide intent to use such mark in interstate commerce.

WHEREAS, subsequent to filing the Application, James Lewis passed away, at which time all of the assets owned by James Lewis, including the Application and Trademarks worldwide and any other registered or unregistered trademarks owned or used by James Lewis or any of his licensees worldwide, as well as, the business associated with such Application and Trademarks and any other registered or unregistered marks, were transferred from James Lewis to The J & D Lewis Living Trust.

WHEREAS, this agreement confirms that the transfer of all of the assets of James Lewis at time of his death to The J & D Lewis Living Trust included the Application and Trademarks worldwide and any other registered or unregistered trademarks owned or used by James Lewis or any of his licensees worldwide, as well as, the business associated with such Application and Trademarks and any other registered or unregistered marks.

WHEREAS, both Assignor and Assignee desire to record with the U.S. Patent and Trademark Office the transfer of the Application from James Lewis to The J & D Lewis Living Trust.
