ASSIGNMENT

WHEREAS, Metform, L.L.C., a limited liability company organized and existing under the laws of Delaware, hereinafter referred to as "Assignor," is the sole owner of the entire right, title, and interest in the United States trademark entitled "AXILOK," having a filing date of November 17, 1989, registration number 1773394, and a registration date of May 25, 1993.

WHEREAS, MacLean-Fogg Company, a corporation organized and existing under the laws of the State of Delaware, having a place of business at 1000 Allanson Road, Mundelein, Illinois 60060, hereinafter referred to as "Assignee," desires to acquire the entire right, title, and interest in and to, the trademark identified above.

NOW, THEREFORE, in consideration of the sum of One Dollar (\$1.00), and other valuable and legally sufficient consideration, the receipt of which by the Assignor from the Assignee is hereby acknowledged, the Assignor has sold, assigned, and transferred, and by these presents does sell, assign, and transfer to the Assignee, the entire right, title, and interest for the United States in and to the trademark identified above; and any trademarks that may be registered in the United States; together with the entire right, title, and interest in and to said trademark and trademark applications therefore in all countries foreign to the United States, including the full right to claim for any such application all benefits and priority rights under any applicable convention; to have and to hold for the sole and exclusive use and benefit of the Assignee, its successors and assigns, to the full end of the term or terms for all such trademarks.


The Assignor hereby covenants and agrees, for both the Assignor and the Assignor's legal representatives, that the Assignor will assist the Assignee in the prosecution of the trademark applications that the Assignee may elect to make covering the trademark identified above; in vesting in the Assignee like exclusive title in and to all such other trademark applications and trademarks; and that the Assignor will execute and deliver to the Assignee any and all additional papers which may be requested by the Assignee to carry out the terms of this Assignment.

The Commissioner of Patents and Trademarks is hereby authorized and requested to register trademarks to the Assignee in accordance with the terms of this Assignment.
