RELEASE OF SECURITY INTEREST

This Release is executed by National City Bank as of the date set forth below.

WHEREAS, on September 28, 2001, National City Bank, a national banking association, Brush International, Inc., an Ohio corporation ("BII"), Williams Advanced Materials Inc., a New York corporation ("WAM"), Circuits Processing Technology, Inc., a California corporation ("CPI"), Technical Materials, Inc., an Ohio corporation ("TMI"), Brush Resources Inc., a Utah corporation ("BRI"), Brush Ceramic Products Inc., an Arizona corporation ("BCP"), and Zentrix Technologies Inc., an Arizona corporation ("ZTI" and, collectively with WAM, CTP, TMI, BII, BRI and BCP "Brush") entered into a Subsidiary Security Agreement, as later amended, granting to National City Bank a security interest in, among other items, the trademarks listed on Schedule A attached hereto as well as future trademarks (the "Trademarks");

WHEREAS, on May 13, 2002, National City Bank caused the lien created in the Subsidiary Security Agreement to be recorded against the Trademarks in the U.S. Patent and Trademark Office on Reel 2522 at Frame 0117; and

WHEREAS, Brush has satisfied all outstanding Secured Obligations (as defined in the Subsidiary Security Agreement);

NOW THEREFORE, for and in consideration of Brush's satisfaction of all outstanding Secured Obligations, National City Bank hereby releases all liens, lien rights, security interests, claims or demands of any kind whatsoever, which National City Bank now has or might have against the Trademarks pursuant to the Subsidiary Security Agreement

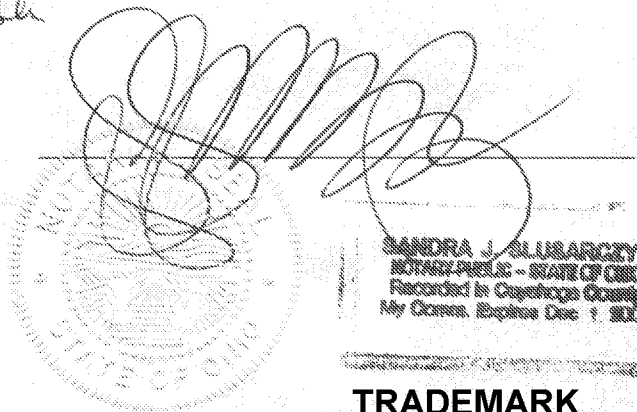
