**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
GRATE TECHNOLOGIES, INC.**

Pursuant to the provisions of Section 607.1006 of the Florida Statutes, the undersigned Corporation adopts the following articles of amendment to its articles of incorporation:

1. The name of the Corporation is GRATE TECHNOLOGIES, INC.
2. Article I of the Articles of Incorporation is hereby revoked and the following Article I is inserted in lieu thereof:

"ARTICLE I.
