This letter is the official certification of the Comptroller of the Currency (OCC) of the merger of Standard Federal Bank, 2600 West Big Beaver Road, Troy Michigan 48084 (OTS Docket No. 0161) with and into Michigan National Bank, 27777 Inkster Road, Farmington Hills, Michigan 48334 (OCC Charter No. 16660), under the charter of the latter and the title "Standard Federal Bank National Association". The head office address of the resulting bank has changed to 2600 West Big Beaver Road, Troy, Michigan 48084. The effective date of the merger and change of head office address was close of business October 5, 2001.
