1. Transfer and Assignment. Assignor hereby transfers and assigns to Assignee all right, title and interest in and to the Marks and Registrations, together with the goodwill associated therewith and the right to recover for damages and profits and other remedies for past infringements of the Marks and Registrations.

2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and/or instruments, and to perform further acts, as reasonably deemed necessary by the Parties, to vest in Assignee all right, title and interest in and to the Marks and Registrations, to enable such right, title and interest to be recorded in the appropriate governmental authority or agency of the United States and reasonably assist Assignee in its efforts to enforce the Marks and Registrations.
