TRADEMARK ASSIGNMENT

THIS TRADEMARK ASSIGNMENT is dated as of November 26, 2002, is made and delivered by Oreck Manufacturing Company, a Delaware corporation ("Oreck") and Oreck Holdings, LLC ("LLC" and together with Oreck, the "Assignors") and Techtronic Appliances Holdings Company Limited, a Bermudan corporation ("Assignee").

WHEREAS, by the Bill of Sale, Assignment and Assumption Agreement, dated November 26, 2002 (the "Agreement"), Assignors agreed to assign to Assignee all common law rights in the trademarks and service marks listed on the attached Schedule A hereto, all applications and registrations pertaining thereto, and all goodwill associated therewith, including the listed applications to and registrations in the United States Patent and Trademark Office and in the Trademark Offices of the foreign jurisdictions set forth therein, together with all the assets of the business conducted under the Marks, and all rights to claims of past infringement thereof (collectively the "Marks"); and

NOW THEREFORE, in consideration of the sum of ten dollars (\$10) and other good and valuable consideration, the sufficiency and receipt of which is hereby acknowledged, Assignor does hereby assign, sell and transfer to Assignee, its successors and assigns, all right, title and interest throughout the world in and to: (i) the Marks, including all applications or registrations therefor and all goodwill pertaining thereto; (ii) the portion of the business of Assignor to which the listed intent-to-use applications apply; (iii) all income, royalties, damages and payments now due or which hereafter become due or payable in respect to thereto; (iv) all causes of action (in law or equity) and rights to sue, counterclaim and/or recover for past, present or future infringement of thereof; and (v) all rights corresponding to the foregoing.

This Assignment is effective as of the date hereof. Assignor hereby agrees to execute all papers and to perform all other proper acts requested by Assignee or its successors or assigns to secure to Assignee or its successors or assigns the rights hereby transferred.
