WHEREAS, ASSIGNEE is desirous of acquiring all rights, title, and interest in and to the Trademarks and Applications worldwide; and



- (2) the Applications set forth in Schedule B;


together with the goodwill symbolized by said Trademarks and Applications concurrent with the transfer of certain tangible assets as indicia of said goodwill.
