WHEREAS, Assignee and Assignor desire to enter into this Assignment to effect the transfer to Assignee of the Mark and Registration;



Assignor hereby agrees to execute and deliver to Assignee any further documents and/or instruments, and to perform further acts, as reasonably deemed necessary by the Parties, to vest in Assignee all right, title and interest in and to the Mark and Registration, to enable such right, title and interest to be recorded in the appropriate governmental authority or agency of the United States and reasonably assist Assignee in its efforts to enforce the Mark and Registration.
