WITNESSETH

WHEREAS, Assignor has adopted and used and is the owner of the trademark "FASHION DESIGNS" and the application for same with the U.S. Patent and Trademark Office, Registration No. 2,802,806 (collectively, the "Mark").


WHEREAS, Assignee desires to obtain from Assignor and Assignor desires to assign to Assignee all right, title and interest in and to the Mark.

Assignor hereby transfers and assigns to Assignee all right, title and interest in and to the Mark, together with the goodwill of the business symbolized by the Mark, along with the right to recover for damages and profits and other remedies for past infringements of the Mark.

2. Further Documentation and Actions. Assignor hereby agrees to execute and deliver to Assignee any further documents and instruments, and to do any and all further acts, deemed necessary by Assignee to vest in Assignee all right, title and interest in and to the Mark, and to enable such right, title and interest to be recorded in the United States Patent & Trademark Office and any other appropriate governmental authority or agency of the United States.
