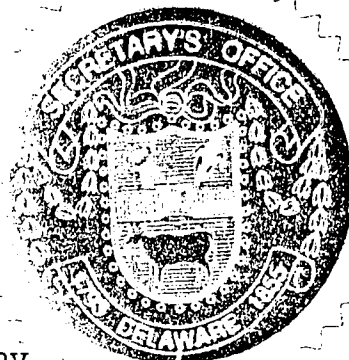

SECOND: That SOTD's original certificate of incorporation was filed with the Secretary of State of the State of Delaware on December 30, 2001.


THIRD: That the name of the limited liability company into which SOTD is being converted is "Snap-on Tools Company LLC".
